

Submission of false or misleading proofs of claim shall attract penalties.

The existing directors and managers of the corporate debtors are requested to ensure compliance of provisions of Section 17 of the Insolvency and Bankruptcy Code, 2016. All existing Bankers/Financial Institutions maintaining the accounts of Corporate Debtors are requested to ensure compliance of Section 17 of the Code.
